

Income management is a destructive, racist policy currently being forced on struggling people in Bankstown and other “trial sites” across Australia.

The system quarantines 50 per cent of the Centrelink payments of certain groups. These funds can not be accessed as cash and can only be spent on certain items at government approved stores.

Income management was first forced on Aboriginal communities in the Northern Territory as part of the NT Intervention. This required the suspension of the Racial Discrimination Act. Now Bankstown is also being targeted as the only “trial site” in NSW.

In Bankstown, the scheme is being rolled out to young people going through hard times. Youth who are “unable to live at home” because of abuse and young people exiting prison are being forced onto income management. Centrelink social workers also have the power to put anyone on income management who they deem to be “vulnerable to financial crisis”.

Income management is very expensive, costing between \$5-8000 per person per year in administrative costs. This money should be going to more support services and job opportunities.

Barbara Shaw, an Aboriginal leader from Alice Springs, is traveling to Bankstown to speak out against income management at the protest on August 23. Barbara believes all targeted communities across Australia need to unite to get rid of income management:

“Income management has made it much harder to look after my family and has made our social problems and the racism we face much worse. More than \$500 million has been spent on income management in the NT - a disgusting waste of funds when my people are in such desperate need”.

The campaign in Bankstown is making a real difference. The government wanted 1000 people on the system in Bankstown every year, but after more than 12 months there were only a handful on compulsory income management. The Public Service Association (PSA), who represent Child Protection workers in Bankstown, have voted to ban income management and have made no referrals.
